## SECTION 5. FIRE-FIGHTING MEASURES

**Methods for containment and cleaning up**

Recover by pumping or with suitable absorbents. Dispose of in accordance with national and/or local regulations relating to waste disposal.

**Water spill:** Stop leak if you can do so without risk. Confine the spill immediately with booms. Remove from the surface by skimming or with suitable absorbents. Seek the advice of a specialist before using dispersants.

Do not store near heat, sparks, open flame, pilot lights, static electricity, or other sources of ignition. Do not store where temperature may exceed 49°C (120°F). Store away from oxidizing agents. Rotate stock.

### Exposure controls
